Men of ages 18 through 25 are required to register with the Selective Service System. This requirement covers U.S. citizens and most other men residing in the United States, except that a man who is in the U.S. as a lawful nonimmigrant isn't required to register as long as he maintains that status (see the exceptions to the registration requirement below). Students who are required to register with the Selective Service must do so to be eligible for financial aid funds.

Exemptions

Men exempted from the requirement to register include:

- Males currently in the armed services and on active duty (this does not apply to members of the Reserve and National Guard who are not on active duty);
Males who are not yet 18 at the time that they complete the FAFSA (an update is not required during the year, even if the student turns 18 after completing the FAFSA);
Males born before 1960;
Citizens of the Republic of Palau, the Republic of the Marshall Islands, or the Federated States of Micronesia\*;
Noncitizens who first entered the U.S. after they turned 26;
Noncitizens who entered the U.S. as lawful nonimmigrants on a valid visa and remained in the U.S. on the terms of that visa until after they turned 26;
Males who were unable to register due to being hospitalized, incarcerated, or institutionalized;
Males enrolled in any officer procurement program at The Citadel, North Georgia College and State University, Norwich University, Virginia Military Institute, Texas A&M University, or Virginia Polytechnic and State University;
or
Males commissioned as Public Health officers on active duty or members of the Reserve of the Public Health Service on specified active duty.

Below is a list of acceptable documentation which you may submit to confirm your Selective Service status. If you submit a document which has an expiration date, additional documentation may be requested in subsequent years. SUBMIT COPIES OF BOTH FRONT AND BACK OF ALL DOCUMENTS. CIRCLE THE LETTER THAT APPLIES TO YOU.

- A. I am female and completed the FAFSA incorrectly.
B. I have registered and have attached a Status Information Letter from the Selective Service verifying that I have met the registration requirement.
C. I am a noncitizen who first entered the U.S. after the age of 26. (Provide documentation that you entered the U.S. after the age of 26 and a letter from the Selective Service System stating that you entered the U.S. after the age of 26 and are exempt from registering.)
D. I am not required to register due to one of the exemptions above. (Please circle the bullet that applies to your situation and provide supporting documentation.)
